



FROZEN SEMEN SALES AGREEMENT

This agreement is by and between "Rideauwood Semen Imports" and _____
(hereinafter "The Mare Owner"), for _____ (mare).

- 1. Rideauwood Semen Imports hereby agrees to sell The Mare Owner frozen semen of _____.
- 2. The Mare Owner hereby agrees to pay, in advance the fee of \$Cdn _____ (+GST) per dose for a total of _____ doses (_____ straws) prior to shipment of semen of the stallion _____.
PLEASE MAKE CHEQUES PAYABLE TO SUSANNE DUTT-ROTH.

3. Semen, along with an "Acceptance of Receipt of Frozen Semen" form will be shipped by Rideauwood Semen Imports upon receipt of payment for semen plus handling and shipping of \$270.00 Cdn (on average) for each shipment.

Rideauwood Semen Imports will ship by FedEx, and will call The Mare Owner with a tracking number. Return shipping costs are included in the \$270 Cdn (on average) shipping cost. The Mare Owner agrees to promptly return the shipping container and the completed "Acceptance of Receipt of Frozen Semen" via FedEx, within 48 hours of receipt of each shipment. There will be an additional \$30.00 Cdn per day on late return of the container.

Please note that Rideauwood Semen Imports has only a limited number of shipping containers. Shipments will be made on a "first come first served" basis. We strongly recommend scheduling shipments well in advance of your breeding date. Please arrange for transfer of frozen semen to a liquid nitrogen container nearby (available at your veterinary clinic or rented from an AI centre). Frozen semen can only be stored in a shipping container for a maximum of five days.

- 4. The Mare Owner warrants that said Mare is in sound breeding condition as determined by a qualified veterinarian. The Mare Owner agrees that the Mare will be bred by a Veterinarian with considerable experience in frozen semen and artificial equine reproduction, and who has access to a veterinary ultrasound machine.
- 5. Breeding certificates will be sent in the shipment, along with the thawing protocol. The Mare Owner and their Veterinarian are responsible for completing and submitting the breeding Certificate that is sent with each shipment.
- 6. This agreement is binding upon the parties herein and reflects the entirety of their agreement. The Mare Owner acknowledges that there is no live foal guarantee for frozen semen contracts.
